Why do agencies need to apply asset management practices to ITS Devices and TMCs?

Asset management practices help agencies:

- Monitor, assess and report on conditions of specific assets
- Integrate the condition of assets into planning for future TMCs investments
- Incorporate condition of assets into day-to-day TMC management and operation
- Improve the allocation of resources needed for routine maintenance, repairs or replacements to improve operational reliability of devices and TMCs
- Explore and initiate activities, resources and methods to establish, conduct, and sustain asset management activities
