Congressional Funding Language

Protection of First Responders - Not less than \$5.0 million is for activities grants, pilot projects, and innovative solutions to evaluate driver behavior and technologies that protect law enforcement, first responders, roadside crews, and others on the job.

- NHTSA is directed to study and report to the House and Senate Committees on Appropriations regarding:
 - The safety and deaths of first responders and other road workers.
 - The development of accurate reporting analysis of crashes that involve police pursuits.
- **Move Over Laws** - USDOT is directed to use a portion of the \$5 million for field testing of technologies and moveable barriers that protect law enforcement, first responders, roadside crews, and others on the job. DOT is to provide a report to the House and Senate Committees on Appropriations summarizing the results of the field testing.

FHWA Led Initiatives

Strategy Focus Based on Congressional Funding:

- Move Over Laws compliance and efficacy.
- Technologies that improve responder safety.
- Moveable barrier solutions.
- First responders and other road worker struck-by fatality, injury research, numbers and causes.
