We request that the broader scene be captured.

Five categories:

- Crashes with responders on scene.
- Safety service patrol response.
- TIM Responder Training (virtual or in person).
- TIM technology in use (UAS, CAD, Video Sharing, Push Bumper, etc.)
- TMC Operations, TIM Committee meetings, or After-Action Reviews.

Please note that if an individual's face is in the picture, we need a model release form from that individual. If the face is not prominent, we can blur the face.

- Prefer 1600x1200+ resolution, minimum 640x480.
- All eligible except FHWA and support contractors.
